### **Akwesasne Presentation**

Angela George concerned over player who was released from Cornwall for the 2006 season to play for Akwesasne. Player moved residence to Akwesasne prior to December 31<sup>st</sup> 2006 and currently resides and attends school in Akwesasne boundaries. Cornwall argues that player belongs to their association because of prior membership.

***Policy MR2.09 (a) Residence Rule***

*This shall be an area in which he/she has been living with his family as of January 1<sup>st</sup> of the playing year. If a player makes a bona fide change of residence after January 1<sup>st</sup> and has qualified with a club, such change of residence must be brought to the attention of the Board of Directors before such a player is entitled to play with the club he first qualified with.*
