

Score/Penalty Reporting and Gamesheet Fines

These fines have been put in place to enhance the accountability of the membership and to keep Zone 5 consistent with the operations across the Ontario Lacrosse Association.

Immediate Score Reporting

In order to facilitate proper recording of scores, it is the responsibility of the home (hosting) association to report scores from every game they play to the Zone 5 Statistician within 48 hours of the scheduled game start time using the score reporting template to be provided by the Zone 5 Executive. It is the expectation of the Zone 5 executive that each association has one designated representative to forward the scores to the Zone 5 statistician (multiple scores can be and should be forwarded at once). Failure to provide scores results in the exact fashion outlined above (meaning all necessary parties copied and proper paperwork used) results in a graduated fine system. The first offense results in a \$25 fine (applies once for all games on date in question), the second offense results in a \$50 fine (applies once for all games on date in question), and the third offense results in a \$100 fine (applies once for all games on date in question). Every occurrence beyond the third offense is levied at \$100 (applies once for all games on date in question). Fines will be assessed to the association on a bi-monthly basis.

Immediate Penalty Reporting

In order to facilitate proper suspension policies, it is the responsibility of the club that has a situation that involves a player receiving game misconduct (GM), match (MP) or gross misconduct (GRM) penalties to report the infraction to the Zone 5 RIC within 24 hours of the occurrence (sending a photograph or scan of a gamesheet is highly recommended). The club who receives the infraction is responsible for reporting the specifics and ensuring the player does not participate in game action until approved by the Zone 5 RIC (it does not default to the home (hosting) association). If, at anytime, you are unsure of the penalty assessed contact the Zone 5 RIC to ensure the situation is handled properly. Communication can take place through e-mail or phone call. Failure to report any of the above infractions (again, if unsure, contact the Zone 5 RIC) within 24 hours results in a \$100 fine. Failure to report the above infractions within 72 hours results in a \$200 fine. Reporting of the infraction beyond 72 hours results in a \$500 fine and immediate suspension of the head coach of the team in question until dealt with by the Zone 5 Discipline Committee. Fines will be assessed to the association on a bi-monthly basis.

If a team uses a player who should have been suspended and the players participation was not approved by the Zone 5 RIC (meaning the club did not report the infraction), the player in question will be suspended indefinitely and the

club fined \$500. For all subsequent offenses involving the use of a suspended player, a \$1000 fine will be levied per violation.

Late Gamesheets

All gamesheets MUST be sent to Zone Statistician within 72 hours of the completion of the game. Please ensure all gamesheets are catalogued based on date. Failure to submit the official gamesheet within 72 hours results in a \$25.00 fine (applies once for all games on date in question). All gamesheets received outside of the 72 hour window result in a \$50 fine (applies once for all games on date in question). If a gamesheet is still not received within 10 days of the completion of the game, a \$100 fine will be levied (applies once for all games on date in question). Fines will be assessed to the association on a bi-monthly basis.
